## Handover report for the London Patient and Public Advisory Group

This report summarises the work of the London Patient and Public Advisory Group (PPAG), introduces its members and outlines the Group's plans for the future of pan-London patient and public engagement in the context of NHS reform and transition to a new system after April 2013.

The diversity of communities and interests across London is reflected in PPAG, whose members also have knowledge of specific clinical areas from a lay perspective and specialist patient and public involvement (PPI) skills. Through involvement in pan-London projects and dialogue with local Local Involvement Networks (LINks), members have gained the experience and knowledge to brief clinicians and contribute to service improvement from a London perspective.

## Background and current work

PPAG's current role is to contribute to the development of healthcare across London by representing the interests of patients and the public within a London-wide group The benefits of patient engagement are well documented, as engaging with patient and public representatives is key to developing services that meet the needs of the people using them.

The Strategic Health Authority NHS London works hard to actively engage with patients in all areas of the organisation, and PPAG has been an important resource in achieving this aim. After April 2013, NHS London will no longer be in existence to support the PPAG group, and consideration therefore needs to be given to the future of the Group following its final meeting in November 2012.

It will continue to be important in the future that issues such as commissioning decisions, patient safety, the safety of users of care homes, the increasing involvement in public health and influencing policy through Health and Wellbeing Boards are approached from both a local and pan-London user perspective.

The NHS London PPAG consists of twenty-one members of the public, most of whom are already active within their local LINks at leadership and representative levels. Members are also involved with their local Clinical Commissioning Groups (CCGs)s, Health and Wellbeing Boards and Local Authorities, as well as pan-London projects such as cancer, cardiovascular, mental health and stroke care.

PPAG members have been expert panel members with a teamwork approach to information sharing with local groups within their Boroughs, and providing feedback to the Group with the overall aim of improving PPAG's effectiveness. PPAG Group members' biographies are given in Appendix A.

The PPAG Group is the only NHS patient advisory group working at a pan-London level as an essential means of informing health and social care policy from the user's perspective. At the national level, the interests of London LINks are currently represented directly with the Department of Health's Healthwatch Team and Healthwatch Programme Board. PPAG and LINks are supplemented by the work of other organisations, such as 14 Healthwatch Pathfinders across London and the Patients' Forum Ambulance Services, an independent body which monitors the London Ambulance Services.

The PPAG members meet as a group on a quarterly basis at NHS London chaired by an independent facilitator to hear from a wide range of speakers from across the health and social care system in London and input expertise at an early stage to pan-London initiatives.

Meeting support is provided by NHS London's communications team. In addition, a regular newsletter is distributed by NHS London to keep the PPAG members up to date on NHS transition, and members are encouraged to share this information more widely.

The Group's members were originally recruited for the Healthcare for London Programme in 2007, and the Group transferred to NHS London in January 2011.

The PPAG Group played a key part in Healthcare for London's Consulting the Capital programme to improve the health of Londoners, helping to make services safer and more accessible by providing a focus on services from a patient's point of view. The Group advised on the consultation strategy and implementation, and reported on its view of the consultation results. These deliberations led to major changes, in particular, in the accessibility to primary care.

The PPAG Group also provided advice to Healthcare for London in the lead-up to the pan-London consultation on stroke and major trauma care in 2009. The consultation concerned the number and location of the new specialised treatment centres.

Two major NHS London programmes were developed with the advice and participation of a cohort of PPAG members. The Cardiovascular and Cardiac Care workstream had a total of 10 lay members, 5 recruited from the PPAG. The contributions of the lay members were highly complimented by the clinical members. This led to the development by the lay members of an ancillary document dealing with issues most relevant to the patient perspective, which was published side-by-side with the clinical treatise.

A second major programme was the reconfiguration of cancer services in London, where 5 PPAG members and 5 patients from the London cancer networks gave patient perspectives to the Case for Change and the Model of Care proposals. As the programme moved into the development and implementation phase, two of the PPAG members were recruited to sit on the newly re-organised patient panel. The latter panel made sure that the Model of Care and its acceptance by the newly created Integrated Cancer Services incorporated the recommendations of the patient panel.

PPAG members have also been strong advocates for 24 hour, 7-day week consultant care.

## PPAG Future Planning Task Group

The PPAG Future Planning Task Group has been created to formulate ideas as to the future role of PPAG in the new NHS system after 2013 and provide a report and an action plan to determine future options for the role of PPAG if a new organisation should wish to host them. This is to help stakeholders and interested parties to gain a better understanding of the potential of PPAG as a London-wide body with strong local links under the new arrangements, and to ensure that important learning and information is not lost in transition.

This also fulfils current NHS London requirements for PPAG members to provide an insight on upcoming issues, and provides evidence of their role in specific projects and of dialogue with local groups. London PPAG have agreed to host a local dialogue on information sharing and feedback with LINks, HealthWatch Pathfinders and patient support organisations and commissioning groups from the north east, north west, and south sub-regions, taking place at NHS London on Thursday 29 November 2012. **Future plans** 

After April 2013, the Strategic Health Authority NHS London will no longer be in existence to support the PPAG group, and consideration therefore needs to be given to the future of the Group following its final meeting in November 2012. Any future role needs to be considered within the context of the NHS reforms and the new commissioning structures that will exist in London.

It will continue to be important in the future that issues such as commissioning decisions, patient safety, the safety of users of care homes, the increasing involvement in public health and influencing policy through Health and Well Being Boards are approached from both a local and pan-London user perspective. A re-constituted PPAG with strong links to local LINks groups would be crucial to achieving these aims by providing advice for Healthwatch and guidance for the emerging NHS related Bodies such as CCGs, NHSCB and Health and Wellbeing Boards. This could take place without the usual 2-year period of development for new bodies to re-build expertise, networks and appropriate systems of patient and public involvement. Members of London PPAG have also agreed to make themselves available to existing and incoming bodies and projects who wish to hear views and receive feedback from a group with pan-London experience.

## Amber Qureshi

Current activities include: co-chair of LINk Southwark, Member of LAS Patients Forum, representing the Forum on the LAS Clinical Quality & Safety Committee; LINk Member of the Southwark Clinical Commissioning Group, Member of the Royal College of Surgeons PLG, representing The Academy of Royal Medical College on the Clinical Committee for Surgical Safety; Guys & St Thomas' NHS Foundation Trust.

## **Beryl Pankhurst**

Beryl has worked in research biology and education. Her particular interests are in health and environmental education, although she has had special responsibilities for equal opportunities. Chief Whip of the London Fire and Civil Defence Authority. He is director of NALM at a national level and Chair of London NALM.

## Michael Vidal

Michael left the civil service in 2007 to pursue other interests. From 2002-2010 he was a London Education Authority appointed governor at Betty Layward Primary School in Stoke Newington.
